PLAINTIFFS' PROPOSED REPORTING
FORMAT UNDER 9/9/90 ORDER

Plaintiffs propose that the quarterly reports contain the following information:

A. the results of HUD monitoring of PHAs' compliance with the tenant selection and assignment plan during the quarter. Each PHA monitored or reviewed should be listed with the results of the review or monitoring and any remedial actions taken by the PHA. [1988 order paragraph #2]

B. each action taken by HUD to exercise its discretion in compliance with paragraph #3 of the 1988 order and a description of the results achieved during the quarter from the exercise of the discretion.

C. Inclusion of any 1988 order paragraph 4 notice given to the class during the quarter in the report.

D. The results of HUD monitoring of non-PHAs' compliance with the requirements of 1988 order paragraph #5. The report should include a listing of any class members actually obtaining desegregated housing by name and project.

E. A summary of all referrals made under 1988 order paragraph #6 and the results of the referrals.

F. A summary of the complaints received pursuant to paragraph #7 and the actions taken by HUD to resolve the complaints and the results of those actions.

G. All actions taken to comply with paragraph #8 of the 1988 order.

H. All actions taken to comply with paragraph #9 of the 1988 order.

I. A list of all CIAP proposals submitted or acted on by HUD pursuant to paragraph #11 of the 1988 order.

J. All actions and the results of such actions taken to consider the factors set out in paragraphs #12 and #13 of the 1988 order.

K. The statements and documents required by paragraph 14 of the 1988 order.

L. Once approved by the Court, the HUD actions to implement the information system required by paragraph #1 of the 1990 order. The report should also include a description of any problems encountered in the timely implementation of the system and the actions taken by HUD to solve the problems.


M. As specific desegregation plans are submitted and approved by the Court pursuant to paragraph 2 of the 1990 order, all actions taken and desegregation results achieved in the implementation of each plan.
