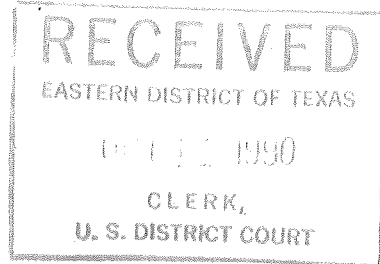

FEDERAL DEFENDANTS' PROPOSED REPORTING FORMAT

The Court, in its September 10, 1990 Order, required that HUD "file quarterly reports giving specific results achieved by each element of the remedy." It stated that each party should submit its proposal for the format and content of the report within 30 days of the Order. This is the federal defendants'<sup>1</sup> submission pursuant to that requirement in the Order.

The federal defendants have reviewed the proposal submitted by the plaintiffs. See Plaintiffs' Proposed Reporting Format Under 9/9/90 Order, served October 9, 1990. Federal defendants are willing to adopt the recommendations contained in plaintiffs' submission. Accordingly, unless directed otherwise by the Court, federal defendants shall include all of the information requested by plaintiffs in its report for the quarter ending December 31, 1990.


