DEFENDANTS' MEMORANDUM IN RESPONSE TO PLAINTIFFS' MOTION FOR INJUNCTIVE RELIEF

Plaintiffs have moved the Court for an order requiring defendants to submit a proposed remedial plan concerning the constitutional and statutory violations addressed in this Court's July 31, 1985 opinion. While not conceding the correctness of the Court's July 31 opinion, or that defendants should alone bear the burden of submitting such a proposal, defendants now agree to do so.

Therefore, defendants will serve a proposal for a remedial plan, in response to the Court's findings and conclusions contained in its July 31, 1985 opinion, on or before December 17, 1985. In plaintiffs' proposed order attached to their Motion for Injunctive Relief, they had requested the Court to order defendants to submit the remedial plan "no later than sixty (60) days from the date of the signing of this order."

Defendants believe that their proposal for a remedial plan can be submitted by December 17, 1985. A proposed order is attached.
